Jeppe High School for Boys Rowing Regatta Notice

1st February 2025

U14/U15 Regatta

This regatta notice is an invitation to all schools and junior rowing clubs to participate in the local regatta hosted by Jeppe High School for Boys Rowing Club.

1. **Venue:** Allan Francis Rowing Course, Roodeplaat Dam.
2. **Date:** Saturday 1st February 2025
3. **Time:** Racing starts at 08h00 (**The rowing course will be closed for training 30 minutes before the start of the regatta**)
4. **Events/ participants:** The regatta will be run in terms of the relevant rules and laws as published in the ROWSA rules of racing, and in terms of the conditions contained in this notice. There will be no progression to finals, all heats will be raced as finals. Medals will be awarded to all 1st, 2nd, and 3rd places in A, B & C events.
5. **Entry fees Spectators:** Non-competing spectators gate entry fee will be R40.00. Competitors/ scholars/ coaches/ Sports Staff - free.
6. **Course:** The course consists of eight fully buoyed straight lanes. Crews are to row to the start between the clubhouse bank and the buoys. Crews disqualified from races or crews which cannot compete in a race must make their way back to the clubhouse between lane eight and the far bank. It is the responsibility of the crews to remain within hearing distance of the aligner to make sure that they hear when their race is called.
7. **Entries**
 - 7.1 Entries close at **17h00 on Monday 27th January 2025**. Late entries will only be accepted if there are empty lanes.

7.2 The draft draw will be published on Wednesday, January 29th. The final draw will be published on Thursday, February 30th, at www.regatta.co.za and distributed to the mailing list available.

7.3 As per the ROWSA directives entries should be made via the internet at (www.regatta.co.za).

7.4 Late entries will be allocated to empty lanes in an order in which they are received. If no empty lanes are available, the late entry will not be accepted.

7.5 Entries into the regatta are governed by the SASRU Rules of Racing.

8. Order of events and time gaps: The organisers reserve the right to alter the order of events, if necessary and only in consultation with school representatives. Club captains' and coaches' attention is drawn to the intervals between races as set out in the Final Draw. Crew entries and boat allocations should be planned around these times. The organisers will not be able to delay the published start times of any races in order to accommodate crew or boat clashes.

9. Catering: Food and refreshments will be available throughout the day.

10. Weather interruptions:

10.1 1. In the event of unsafe weather, the President of the Jury shall make all decisions regarding safety and whether racing should proceed as per the event schedule. If the regatta is delayed, the President of the Jury, in consultation with school representatives, will decide on proceeding races, based on the time available.


10. 2 If it is not possible to complete the regatta, the GSRF Executive shall decide to declare the regatta "cancelled" or "complete".

11. Indemnity: The entering of your school or members serves as an acceptance of Indemnity in this regatta, namely that you declare that you accept your own risk and indemnify the Regatta Organisers, Sponsors and Officials of this rowing regatta against any claim of whatsoever nature and howsoever arising, which may result from your schools, club and/ or your rowers' participation.
